suspended in wartime and government officials who violate the law are not beyond the reach of justice Ironically the case also represented a watershed on the path of sectional reconciliation By ruling in favor of the Lee family the justices demonstrated that former Confederates would receive a fair hearing in the federal courts Gaughan provides a riveting account of the Civil War s final battle a struggle whose outcome became a significant step on the path to national reunion
