Corporate governance attributes and financial reporting quality: An evidence from a developing country in Africa

ABSTRACT

The study's objective was to analyse the relationship between corporate government attributes and financial reporting quality from a developing country perspective. Data was collected through militative content analysis of annual reports and audited financial statements (2012 to 2018) of Zambian listed companies. This was a longitudinal study that secolved panel data analysis. Therefore, a Maximum text was conducted to select the model to use. Panel regression analysis was used as a data analysis technique. Results above a statistically significant positive relationality between board size and financial reporting quality. A positive but statistically insignificant relationship existed between bound accounting expertise, board gender diversity, andit committee independence and financial reporting quality. A negative that insignificant relationship existed between board independence and financial reporting quality. The corporate governance system alone cannot guarantee quality financial information by reporting entities. This could be related to the lack of an effective corporate government system. Therefore, authorities must consider strougthening the regulatory enforcement mechanisms to ensure that companies achieve high financial reporting quality.

Introduction

The quality of financial information is determined by the quality of accounting standards and enforcement of compliance with the standards (Kontari, 2001). International Financial Reporting Standards(IFRSs) are high quality accounting standards that have been adopted by 80% of the world jurisdictions for the purpose of promoting quality corporate financial reporting (Hoogervorst, 2016). Regulatory enforcement is the most important factor in determining compliance with IFRSs and subsequently improve financial reporting quality (Hellman et al., 2018; Christensen et al., 2015). However, in developing countries the regulatory enforcement mechanisms of IFRS compliance are weak (Ali et al., 2004; Saudagaran, 2001). Worse still, African countries are plagued with low compliance with global standards such as IFRSs due to the weakness in the institutional and enforcement mechanism (Word Bank. 2019; Boya and Perera, 2012; Nobes, 2011). Moreover, the challenges of compliance with IFRSs and financial reporting quality are associated with the country specific institutional setting such as legal and political system, enforcement, corporate governance code and firm's financial reporting incentives (Nobes, 1983; Meek and Saudagaran, 1990; Soderstrom and Sun, 2007).

Notwithstanding the institutional setting and strong enforcement mechanisms, the quality of financial information will depend on the behaviour of company management towards financial reporting quality. However, agency theory postulate that the agent (i.e. management) is likely to behave in an opportunistic manner in order to maximize their self-utility and may only disclose information beneficial to them (Panda and Leepsa, 2017). Consequently, this may contribute to information asymmetry which can be severe in a developing country due to limited source of information and, financial reporting is the main source of information. This has the potential to put the primary users of financial information at risk of making unsound economic decisions. Ultimately, corporate governance may play a key role in determining the quality of corporate financial information since it is a system put in place to monitor the behaviour of manages and reduce the agency problem (Eisenhardt, 1989).
