Circulaire over de gevolgen van het nieuwe belastingstelsel 2001 voor gemeente predikanten

Doel van deze circulaire

In de afgelopen periode zijn met regelmaat publicaties verschenen over het nieuwe belastingstelsel in relatie tot de predikanten.

Predikanten vragen in toenemende mate om informatie, over hoe te handelen om in 2002 op een correcte wijze het formulier voor de inkomstenbelasting over 2001 te kunnen verzorgen. Ook van de zijde van de plaatselijke gemeenten, bereiken ons vragen over het nieuwe belastingstelsel.

Het doel van deze circulaire is om de informatie die tot nu toe is verschenen bijeen te brengen en daar, waar ons inziens nodig, aan te vullen.

Dit betekent niet dat onderstaand alle publicaties integraal worden weergegeven. Het gaat om een algemeen totaaloverzicht van de voor dit moment van belang zijnde zaken en voor zover tot heden de informatie beschikbaar is.

2. Algemene introductie

Zoals inmiddels bekend mag worden verondersteld, is per 1 januari 2001 het nieuwe belastingstelsel in werking getreden.

De eerste indruk was dat er voor de predikanten heel erg veel veranderde.

Bij nadere bestudering blijkt dit mee te vallen. Wel dient op voorhand hierbij te worden opgemerkt, dat nog moet worden afgewacht hoe de belastingdienst met een aantal aspecten van de nieuwe Wet Inkomstenbelasting zal omgaan. Dit kan zelfs per afzonderlijke belastinginspectie tot verschillen leiden.

Ongetwijfeld zullen er in de loop van de eerstkomende jaren interpretatieverschillen ontstaan. Pas nadat jurisprudentie is ontstaan over deze interpretatieverschillen zal omtrent bepaalde fiscale aspecten duidelijkheid ontstaan.

Op dit moment is aan de orde welke veranderingen met welke gevolgen nu relevant zijn voor de predikanten en dit dan uiteraard in vergelijking met de situatie vóór 2001.

Veel is geschreven over de verplichting tot het voeren van administratie. Hierop zal uitvoerig worden ingegaan.

Vooruitlopend hierop zij alvast opgemerkt, dat ook reeds vóór 2001 sprake was van het bijhouden van de administratie door de predikanten om te kunnen aantonen welke uitgaven voor de ambtsuitoefening waren gedaan.

Zeker vanaf 2000 was dit weer actueel, omdat met ingang van dat jaar de twee forfaitaire groepsregelingen door de belastingdienst zijn afgeschaft (administratie- en bureaukosten en de representatiekostenvergoeding). En het zijn met name deze kostencategorieën die dikwijls aanleiding
geven tot "fiscale discussie". Wel kan worden vastgesteld, dat het nieuwe belastingstelsel nadrukkelijker dan voorheen regels stelt aan de wijze waarop administratie moet worden gevoerd.

Overigens geldt voor de predikanten dat hierbij sprake is van een betrekkelijk mild regime. Zie paragraaf 4.

Het nieuwe belastingstelsel op hoofdlijnen

Het meest in het oog springende kenmerk van het nieuwe belastingstelsel is de invoering van de zogenaamde inkomenboxen. Het gaat hierbij om de volgende inkomenboxen:

- Box 1: inkomen uit werk en woning,
- Box 2: inkomen uit aanmerkelijk belang,
- Box 3: inkomen uit sparen en beleggen.
