- CRA's do thorough research of a company's current financial position and future prospects, from which they assign a rating.
- The higher the rating the more credit-worthy the company's debt instruments are.
- The lower the credit rating the more risky a company's debt securities are, meaning that investors will demand higher interest rates to invest. This will make debt funding more expensive.
