La mayoria puede imponer su voluntad politica sobre las minorias. Para tratar de evitar estos peligros se suele exigir una mayoria calificada para la aprobación de determinados asuntos de especial interès. Esto ocurre no sólo a nivel político, con la aprobación de determinadas leyes, sino también en el mundo empresanal. Así, en ciertos casos, para decisiones trascendentes de las empresas, los directorios se rigen por mayorias cualificadas superiores al 51 por 100.

La paradoja del voto

El problema más importante que afronta una sociedad a través del proceso político es cómo conciliar las diferentes opiniones e intereses de sus miembros.

Una de las dificultades que plantea la toma de decisiones a través del sistema político es el conocido como la paradoja del voto (véase Nota complementaria 4.6). Este problema conserva Nota que un grapo de personas y la sociedad en general puede que no sean capaces de ordenar distintas posibilidades por medio de la votación por mayoría.
